CVMC is now accepting applications for Projects implementing the California Water Action Plan in the Coachella Valley.

Grant Eligibility

Eligible applicants include state and local public entities, nonprofit organizations, tribes recognized by the state or federal government, and mutual water companies.

Any project that fulfils one or more of the objectives of Proposition 1 is eligible for consideration, but the Conservancy specifically encourages applications for:

- (a) Conservation land acquisition projects that: preserve watershed features or water flows into the aquifer, Salton Sea, or local streams; or prevent flooding or contain habitat for endangered or threatened species that are part of the ecosystem of the watershed, Salton Sea, or local streams.
- (b) Watershed restoration or enhancement projects, such as those that reclaim natural features like streambeds, washes, or percolation areas, remove invasive species that draw water from the aquifer or harm endangered species habitat, or create new refuge or habitat areas.
- (c) Infrastructure projects that improve water management or delivery structures to reduce water use or enhance efficiency in a manner that complements surrounding habitat values.

Projects that meet more than one objective will receive priority for funding. Refer to the attached CVMC Proposition 1 Grant Program Guidelines ("Guidelines") for more details on eligibility. Refer to EXHIBIT A for a list of projects that have been approved by the Conservancy Board for award of a Local Assistance Grant.

Application Process and Deadlines

Step 1: Participate in a Pre-Application Consultation with Conservancy staff to present and discuss drafts of the project description, budget, and schedule. In addition, we will address environmental review requirements if applicable, and collect information needed for the consultation corps review if it applies to the specific project. LAST DAY TO REQUEST A PRE-APPLICATION CONSULTATION: FRIDAY, JANUARY 31, 2025.

Step 2: File a written Application for Local Assistance Grant (using the form to be provided at the Pre-Application Consultation) and include responses to all questions in the Project Narrative Instructions found in the Guidelines. The Application and supporting materials must be in PDF <u>and</u> Word/Excel formats and must be submitted to <u>drosas@cvmc.ca.gov</u>.

DEADLINE: APPLICATIONS MUST BE RECEIVED BY CVMC'S OFFICE NO LATER THAN 5 PM ON WEDNESDAY, MARCH 26, 2025.

NOTE: Applications will NOT be accepted from applicants who did not participate in a Pre-Application Consultation. Late applications may be considered in future rounds of funding.

Applications will be reviewed, scored, and ranked in accordance with the competitive process established by Proposition 1 and the Guidelines, with final awards to be made by the Conservancy Board. The Board reserves the discretion to award available funds in this round of funding based on the strength of responses to this NOFA. If funds remain, one or more additional NOFA(s) will be issued in 2025.
